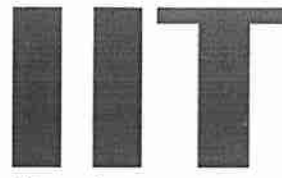

The terms & conditions are once again appended below for case of reference:-

1. Number of Scholarships: 01
2. Amount of Scholarship: Rs. 15,000/- per semester.
3. The need based Scholarship to be given to a student every year in the II<sup>nd</sup> Semester who scored a minimum SPI of 7.0.
4. The Scholarship shall be continued in the subsequent semesters only on the condition that he/she scores a minimum of 7.25 SPI.
5. In addition to above a sum of Rs. 25,000/- shall be awarded as a Cash Award to a meritorious student based on his/her CPI at the end of 5<sup>th</sup> Semester. The student's performance in projects/internship may also be taken into account while deciding the same.
6. The Cash Award shall be given away during the Institute Day.
