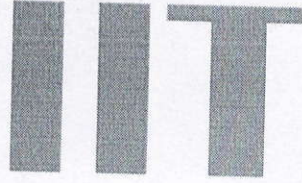

NOTICE FOR FINANCIAL BID OPENING

Reference: Open tender no. IIT(BHU)/IPCCell/FPC/2016-17/926 dated: 19.11.2016 regarding rate contract for supply of furniture items at IIT(BHU), Varanasi.

Total 12 bids were received till the last date i.e. 12th Dec., 2016 uptill 03.00 P.M., 12 bids were opened on the same day at 04.00 P.M. in the Committee Room, Admin building in the presence of bidders representatives. The 11 valid bids were evaluated by the committee as per the advertised tender evaluation criteria.

Accordingly the committee recommended the following:

- (i) The Committee recommends that the financial bids of 7 bidders namely M/s. Godrej & Boyce Mfg. Co., M/s. Delite Kom Ltd., M/s. Citizen Industries (for lab furniture), M/s. Amerdeep Designs Industries (I) Pvt. Ltd., M/s. Jalaram Steel Furniture Pvt. Ltd., M/s. Methodex System Pvt. Ltd., M/s. Creatika Office System be opened, because of meeting the minimum essential pre bid eligibility criteria and obtaining minimum cutoff marks in the technical evaluation criteria.
- (ii) The financial bids of the following four bidders be not opened because of the reasons mentioned against each:
 - (a) M/s. King Furniture because of not meeting the essential pre bid eligibility criteria at S.No. 2.
 - (b) M/s. Anmol Furniture because of not meeting the essential pre bid criteria at S. No. 4.
 - (c) M/s. Superq Systems Pvt. Ltd. because of not obtaining minimum 25 cutoff marks in the technical evaluation criteria.
 - (d) M/s. Twenty First Century Techno Product Pvt. Ltd. because of not obtaining minimum 25 cutoff marks in the technical evaluation criteria.
- (iii) The Financial bids will be evaluated on the basis of offered prices, suitability and economy of the procurement against the Institute requirements.

The above recommendations were approved by the competent authority vide order dated 20.02.2017.

Accordingly, the 7 qualified bidders or their authorised representative as recommended by the committee at S.No. (i) above are requested to be present during the financial bid opening, which is scheduled to be held on **11.03.2017 at 14:30 hrs.** The venue of the financial bid opening will be **Committee Room, Ground Floor, Administrative Building, IIT(BHU), Varanasi.**
