**Spectrometer for Fluorescence measurements having provision for integrating sphere.** Spectrometer must have high end cooled CCD detector for low noise and high dynamic range. To extend the dynamic range spectrometer with neutral density filter wheel and shutter function will be preferred. System must be computer controlled with user friendly software. There must be option for connecting the integrating sphere (150 mm diameter) to spectrometer through fiber cable to measure the quantum efficiency of samples (powder, film and solution phase samples).

Instruments with following specifications will be preferred:

- i. Integrating sphere (150 mm diameter) suitable for fluorescence measurement of powder, thin film and solution samples. It should work in 200-1100 nm wavelength range.
- ii. Spectrometer with Czerny-Turner configuration.
