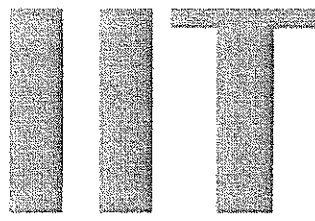

Sub: Protection of Pay on appointment on higher position in the Institute.

Sir,

I am directed to convey the following resolution of BoG vide No. 7.35 dated 25.05.2018 on the subject cited above:

"A person, who is already a confirmed employee in service under any government organization/University/Autonomous Body etc. having similar pay & DA structure and applies through proper channel, joins a post in the Institute on probation after tendering technical resignation to his previous employer and his presumptive pay is more than the entry pay of the post, he will continue to draw such presumptive pay along with admissible increment during probation period. On confirmation on the post at the Institute, after the expiry of probation, he will have his pay fixed under FR 22 (1). This will apply for employees of the Institute also who are appointed on higher position through open recruitment.

A person, who is employed in Public Sector Undertaking (PSUs), Universities, Semi – Government Institution or Autonomous Bodies etc. having different pay & DA structure and applies through proper channel, joins a post in the Institute on probation after tendering technical resignation to his previous employer, his pay will be regulated as per the OM No. F No. 12/3/2017-Estt(Pay-I), dated 28.07.2017 of DoPT, Ministry of PPG & P, Gol.

I am further directed to request you to inform all the employees working under your Department/School/Unit to apply for protection of pay through proper channel if they fall under above categories to the Office of Faculty Affairs or Office of the Registrar, as the case may be, for necessary action in this regard.


