- 2. Delivery- General delivery period is 2-4 weeks and for bulk purchases, delivery period is 6-8 weeks.

- 4. Tax-GST, as per the Govt. norms shall be separately levied upon the discounted price.
- 5. Payment- 100% payment on bill basis against delivery of items at IIT(BHU), Varanasi premises and subsequent installation, if required.
