Title of the project: Development of enzyme enhancement treatment for neuronopathic Gaucher disease.

Duration: Three years. The post is purely temporary and co-terminus with the project.

Fellowship Amount: Rs. 28,000 + HRA (as applicable) per month

Essential qualifications: First class degree in **M. Pharm/M. S. (Pharm.)/M. Tech (Pharm)/M. Tech in Pharmacology and related disciplines with GATE/GPAT/CSIR-NET or equivalent qualifications.** The candidates should have a basic degree in pharmacy (B. Pharm). 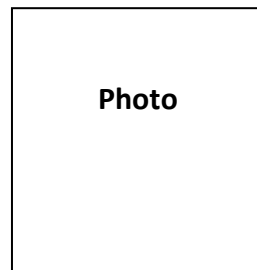
