

## INSTRUCTIONS FOR SUBMISSION OF ACADEMIC FEE

All candidates (except Preparatory Course, JEE(Advanced)-2021 qualified) are required to pay the academic fee online, on or before **November 25, 2021** and upload the e-receipt at the time of online registration.

**Step 1:** Go to the URL: [www.onlinesbi.com/prelogin/icollecthome.htm](http://www.onlinesbi.com/prelogin/icollecthome.htm)

**Step 2:** Click the “**Checkbox**” proceeding to the statement “I have read and accepted the terms and conditions stated above”, and then Click “**Proceed**” button.

**Step 3:** Select State of Institution “**UTTAR PRADESH**” and Select Type of Institution “**Educational Institutions**” and then Click “**GO**” button

**Step 4:** Select Educational Institutions Name “**INDIAN INSTITUTE OF TECHNOLOGY (B.H.U.), VARANASI**” then submit.

**Step 5:** Select Payment Category “**ACADEMIC FEE**”

**Step 6:** Fill in your **JEE (Adv.)-2021 Roll No.** in the field of Roll No., Full Name, Name of Guardian, Mobile number and Email Address.etc.

Select your Category (GEN/GEN-EWS/OBC-NCL/SC/ST), your Class (BTech/ BArch/IDD), Session (2021-22), Semester (I Sem) and your Department from the drop-down menu.

Fill in the Academic Fee amount applicable to your category, as per the amount mentioned in the following table.

**Step 7:** Verify all your entries and selections in the fields and Click “Submit” and to see the confirmation page. Verify the data displayed on this page and Click “Confirm” to proceed further to select the “Mode of payment”. You may choose either Net Banking or Card Payments or Other Payments as per your convenience.

**Step 8:** After making the payment successfully, you will be able to download the e-receipt of the payment. You will have to submit a copy of this e-receipt at the time of registration.
