No. CCIT(E)/Order u/s 80G(2)(a)(iiif) /IIT(BHU) /2016-17/ 176

In exercise of the powers conferred by the Sub-Clause (iiif) of sub-section 2(a) of Section 80G of the Income-tax Act, 1961 (43 of 1961), the prescribed authority hereby notifies - Indian Institute of Technology (BHU), Varanasi -, as a university of national eminence, for the purposes of the said sub-clause, subject to the following conditions namely:-

- (i) The Indian Institute of Technology (BHU), Varanasi - University of National Eminence -, will apply the amount of donation received wholly and exclusively to the objects for which it is established;
- (ii) In respect of the donations received under the aforesaid provisions and expenditure made therefrom Indian Institute of Technology, Indore - University of National Eminence -, shall maintain separate books of account; and
- (iii) A copy of account of each accounting year shall be submitted to the prescribed authority by the following 31<sup>st</sup> December.
